Community Ambassador Project (CAP) Mini-Grants

Engaging Greenbrier County Communities to Improve Health and Health Equity

Overview of Community Ambassador Project Mini-Grants: A little money goes a long way when it's in the hands of community leaders with a solid plan. CAP mini-grants are an opportunity for Community Ambassadors to lead projects that make a difference for their community.

Someone who has never written a grant should be able to complete this mini-grant application in less than two hours.

Quick bullet points about the mini-grant process

- Mini-grant funds are used to create projects in Greenbrier County to promote health and health equity (in other words, to strengthen the health of people in our communities).
- Along with the opportunity to apply for mini-grant funds, GCHA will provide Community Ambassadors access to workshops, evidence-based resources, assistance with data and evaluation, assistance with the development of mini-grant plans, and stipends to value Ambassadors' time when attending workshops and meetings.
- Ambassadors must identify a local non-profit organization to receive the mini-grant funds on their behalf and support the fiscal management or "pass through" of funds. (A W-9 tax form from your sponsoring non-profit must accompany this application). If you don't have a non-profit organization to work with, GCHA may be able to act as your sponsoring organization.
- Projects must promote cooperation and partnerships in the community, not competition.
- Community Ambassadors will document lessons learned and submit a mini-grant report.

Amount of mini-grant award: Ambassador Mini-Grant awards are generally \$1000 for implementation of projects which can last for up to a year. (Actual project duration varies).
